2. Unforeseen health reasons determined by the breeder that prevent the puppy from being sold.

- No deposit. On the date of sale, the monetary funds shall be delivered to the Seller and the dog shall transfer possession to the Buyer. Any outside or other arrangements made by the Buyer and Seller will not be recognized unless stated in this agreement.

*The sales date above reflects an estimate of the delivery date and cannot be guaranteed until the litter is born. It will be up to us, the breeders, to decide when the puppy will be ready to go to its new home. Usually at the age of 8 weeks, depending on the breed, weight of the puppy and how easily it is weaned from the mother. At 4 weeks pictures/videos will be made available to the buyer for selection in order of deposit priority. We will not, under any circumstances, let the puppy leave before it is ready. There is an additional \$20 a day charge for puppies kept longer than 8 weeks of age.
